Historical/other items of interest

- Company traces origins to 1949 establishment of Kahului Development Co., Ltd. (KDCo.), formed to develop and market what soon became known as Dream City (14 increments of 3,500+ fee-simple homes, with special discounts for employees of A&B. These still represent virtually the entire stock of housing in Kahului, Maui. (First residents moved in, in 1950.)
- Kahului Shopping Center, the first integrated shopping facility west of the Mississippi, opened in 1951. Following a fire in early 2005, the company has initiated redevelopment plans.
- KDCo. changed its name to A&B Properties, Inc. in 1975, reflecting its expansion of property development activities to other islands.
- Over the years, A&B and its subsidiaries have donated or leased at nominal charge numerous parcels of land to the community for public purposes such as low- and moderate-income housing, parks and schools.
- A&B was the original master-planner and developer of the Wailea Resort, beginning in the 1970s and continuing until A&B sold the resort to the Shinwa Golf Group in 1989. In October 2003, A&B purchased 270 acres from Shinwa and is master developing the remainder of Wailea.
- Since 1999, A&B Properties has acquired or invested in 27 projects in Hawaii outside its core land holdings in Maui and Kauai. These transactions represent a total capital commitment of more than \$740 million.
